Introduction

1. This World Wide Web (www.leducbookkeeper.com) site is provided for use of the public by Bookkeeping and More
2. Information presented on www.leducbookkeeper.com is considered private information and may not be distributed or copied without authorization.

Information collected and stored automatically

1. The information we learn about you from your visit to our website depends upon what functions you perform when visiting our site.
2. For site management, information is collected for statistical purposes.
